

# 2025 FFTM22 Spring Fling Black Sea Bass Tournament Rules and Information

*It is your responsibility to read and understand the rules and regulations.*

## Entry Fee

- \$100.00 per person for Adult Angler Division
- \$15.00 per person for Junior Angler Division (12 and under)
- The entry fee is non-transferable and not refundable.

## **Registration includes:**

- Eligibility for specific category division prizes and Catch 22 Shoutout prizes
- Eligibility for the 22-tagged Black Sea Bass Challenge with potential payouts up to \$22,000 (details below)
- Exclusive Captain's Bag (adult or junior division) - Registration by midnight, May 5th to qualify as bags and the gear inside each bag have to be ordered with lead time.

Adult size hooded UV-rated tech tees with the new tournament logo can be purchased at checkout for \$35. Orders must be placed by May 14th. All shirts are special order due to sizing, cannot be exchanged, and are final sale.

## Tournament Check-In and Captain's Bag Distribution

**Participant check-in and kickoff event is Thursday May 29<sup>th</sup> from 1pm to 7pm.**

During check-in, participants will receive their Captain's Bag, t-shirts (if purchased), and additional pertinent information. A printed set of rules will be in each Captain's Bag.

*At registration checkout, you must select one of the following locations for check-in and to collect Captain's Bag. **The registration lists will be specific to each location with captain's bags for those registered anglers only.** There are not enough additional captain's bags to overstock each location.*

## Prize Categories

The combined weight of a registered angler's three heaviest Black Sea Bass over the weekend determines the three grand prize winners. In the event of a tie, the registered angler with the first registered fish wins.

(Based on the angler's three heaviest fish over the three days of the tournament period.)

### **Adult Division Grand Prizes**

- \$3,000      Check
- \$1,500      Check
- \$750        Check

### **Junior Division Grand Prizes**

1. \$250.00 (Maco's gift card)
2. \$125.00 (Maco's gift card)
3. \$75.00 (Maco's gift card)

## **Catch 22 Shootout: \$200**

After grand prizes and excluding grand prize winners, each angler is eligible to win one of 22 prizes of \$200 in the Catch 22 Shootout category for the 22 heaviest fish. Each angler can claim only one grand prize or only one Catch 22 Shootout prize.

## **Preamble to the 22 Tagged Black Sea Bass Challenge**

Fishing for Mission 22 presents the \$22,000 Tagged Black Sea Bass Challenge, similar to "hole-in-one" contests at golf events. In collaboration with the Massachusetts Division of Marine Fisheries, twenty-two specially tagged black sea bass will be released into Buzzards Bay. Tagging and release of the black sea bass takes place within 72 hours of the start of the tournament in MA waters ensuring random dispersal. To be eligible for the prize, the catch of a tagged black sea bass must occur during official tournament hours. Registered Anglers who catch these tagged fish and present the fish with the tag still inserted will be awarded \$1,000 for each of these fish. This opportunity allows participants to catch multiple tagged fish, with a total potential of \$22,000 in prize winnings. The number 22 represents the daily loss of veterans to suicide, and this portion of the event aims to honor them and raise awareness for veteran suicide prevention.

## **Eligibility Criteria for Tagged Fish**

When a registered angler catches a tagged black sea bass during the tournament, they must present it to officials for tag inspection. Officials will examine each tag for authenticity. To ensure integrity, anglers with a tagged fish may undergo a polygraph test before receiving prizes. Tag replicas will be shown during captain's check-in on May 29<sup>th</sup>.

## **IMPORTANT NOTES ON RULES AND PRIZES**

- Fishing hours ("Lines In") are from May 30, 2025 at 5am to Sunday June 1, 2025 at 12pm ("Lines Out").
- Participation and prize eligibility is exclusive to registered anglers only.
- Each angler can only be eligible for one Grand Prize Category or one Catch 22 Shootout prize.
- All anglers are eligible to receive the \$1,000 for catching a Tagged Black Sea Bass regardless of whether they win a Grand Prize or a Catch 22 Shootout prize however these fish cannot also be used to win another category.
- Each angler has to present their own fish for weigh-in. ID's will be verified with registration list.
- The eligible species is Black Sea Bass, with a minimum size of 17 inches for weighing. Each angler can weigh in only 4 fish each day of the tournament.
- The total prize pool and awards for the three-day event exceeds \$32,000. Total prize payouts and individual prize categories are estimated based on a minimum of 300 adult registrations. Prize values may be adjusted if the minimum of 300 registrations is not met. Prizes may increase with additional sponsorships. All prizes will be presented at the awards party on Sunday, June 1, 2025. If winners are not present, checks may be mailed or picked up at the FFTM22 Resource Center. In a tie, the earliest registered fish wins. Winners are responsible for any taxes and incurred from prize winnings. A completed IRS 1099-MISC tax form and matching ID is required for prizes \$600 and over. Checks will be issued after proper documentation has been received.

## **TOURNAMENT REGISTRATION**

Please note that we will not be able to answer questions about the tournament via our listed phone line during the tournament, as this line is dedicated to providing assistance to veterans in crisis and must remain open to address their needs.

***All fish will be weighed in prior to the awards party at:***

***Scales will open at 10am and close at 2pm. Fish will be weighed for all anglers that check in with the weighmaster and are in the queue by 2 p.m. This cutoff will be strictly adhered to without exceptions.***

## **Awards Party**

After the tournament, the awards ceremony will also be held at Railroad Bridge Park Pavillion, located at 90 Main St, Buzzards Bay, MA 02532, from 2 p.m. to 5 p.m. The ceremony will feature raffles, a beer garden sponsored by Stone Path Malt, Food from Mincle Boys Catering will be on site as the official food vender. This awards party is open to the public as we aim to raise awareness and advocate for the prevention of veteran suicide. We will also have an open house at our resource center during the event, which is directly across the street from the Pavillion at 47 Main St, Buzzards Bay, MA 02532.

## **WEATHER**

The safety of everyone is of utmost importance and we are all responsible for making the best decision for our own individual safety. The tournament will proceed rain or shine and may not be rescheduled. Participants enter the tournament at their own risk and are responsible for their own safety.

## **PROTESTS/COMPLIANCE**

A registered angler may protest another angler's catch by submitting a written protest to the tournament committee. Such protests must be filed within ten minutes of the last fish being weighed in by the weighmaster. The Tournament Committee will address and resolve any protest, with their decision being final. Noncompliance with any tournament rule, regulation, or applicable Massachusetts State Fishing guidelines may result in the disqualification of an angler or their catch and the loss of any prizes. Disqualified anglers will not be entitled to any prizes, awards, or refunds.

## **DISCLAIMER OF LIABILITY**

All participants and guests assume full responsibility for their personal safety and property, expressly acknowledging the risks associated with tournament participation. As a condition of entry and registration, participants agree to release and hold harmless the tournament's affiliates from any claims related to injuries, death, or property damage incurred during the event. By participating in the Spring Fling Tournament, entrants agree to this liability release and cannot retract it.

The Tournament Committee reserves the right to amend rules and regulations to maintain the integrity of the tournament. The Committee also reserves the right to cancel the event due to safety concerns, including inclement weather, acts of God, or other uncontrollable factors. In the event of cancellation, prizes will be distributed via a lottery among all registered participants, with the number of prizes proportionate to signups and sponsorships. **No refunds will be issued; participation is at one's own risk.**

This fundraising event supports our therapeutic fishing and marine vocational programs, behavioral services, and resource center. It also aims to raise awareness about the more than 22 veterans lost to suicide daily in the U.S. This family-oriented event will host veterans, active-duty members, and military supporters. We expect all attendees to show the utmost respect and courtesy. Unsportsmanlike conduct may lead to immediate disqualification and potential exclusion from future FFTM22 events.
